xxvi) The Trust shall be for the benefit of the institutions to be created by this Trust and the institutions so created by this Trust shall be only beneficiaries.

6. MANAGEMENT OF TRUST:

This Trust shall be administered by a Board of Trustees whose number shall not be less than 2 or more than 10. The founders (the First Trustees) shall be the permanent Trustees. The remaining shall be co-opted and/or nominated. The permanent Trustees may nominate other Trustees and they will be called "Nominated trustees". So however, the total number of permanent Trustees and co-opted and nominated Trustees shall not exceed 10.

The Trustees shall elect the Managing Trustee, Chairman, Treasurer and Secretary from among themselves once in 3 years.

7. FIRST TRUSTEES:

shall be 3 years. Thereafter they will automatically retire from their incumbency of office. However, the retired Trustees shall be eligible for reappointment.

9. VACANCIES AND RESIGNATION.

A Trustee shall cease to be in office with immediate effect on his becoming insolvent or insane or on being convicted for any offence involving moral turpitude or at resignation. Any vacancy occurring in the office of Trustees whether permanent or nominated including those caused by retirement shall be filled by the permanent Trustees, either unanimously or with the consent of the majority. The existence of vacancies in the office of the Trustees shall not invalidate any act or decision by the Board of Trustees. Any trustee may at any time resign his office of Trusteeship by giving one month's notice in writing to co-trustees and upon the expiry of the period of one month such Trustee shall be deemed to have vacated his office. The office of the Trustee falling vacant either by death or by resignation or expiry of 3 years period may be filled by nomination by the Chairman/Chairman of the Trust. However, Trustees can be reappointed as per the decision of Chairman/Chairman of Trust.

10. POWERS AND FUNCTIONS OF THE BOARD OF TRUSTEES:

Trustees shall have full power and authority to administer the Trust Property. The investments shall be in accordance with the provisions of Sections 11 to 13 of the Income-Tax Act

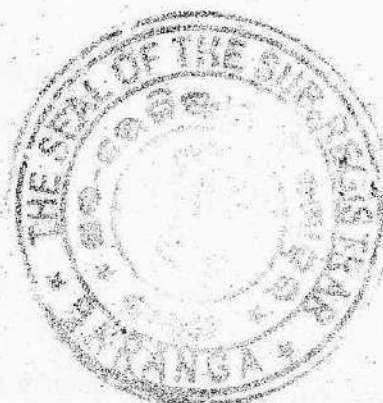

- (c) subject to any mandatory provision of any law for the time being in force and applicable to the trust, the board of trustees shall invest all money which shall require investment in any investment of properties of whatsoever nature and whatsoever situation and whether having liabilities or producing income or upon personal credit with or without security and in the manner authorized by law and the Income Tax Act, 1961 or as may be in force from time to time for the invest of the trust funds and to call in, sell, convert or exchange such investments and properties both movable and immovable, whenever, they in their absolute discretion think it desirable to do so.

- (h) to do all or any of the aforesaid things, transactions or matters and do all such other things, transactions or matters as are incidental or conducive to the attainment of aims and objects of the Trust.
- (i) to employ persons to assist the Trustees in carrying out the Trust purposes. They can terminate their services when it is not required and it is for betterment of the Trust.
- (j) to purchase, construct, hire or take on lease any immovable or movable property for all or any of the purposes of this Trust at such price, cost or rent and
